All Not for Profit organizations had to update/resubmit their constitutions to Industry Canada. We were ahead of the rush because we adopted a new constitution in 2011.

Recently Industry Canada had returned our constitution to our legal counsel asking that **Section 9 Statement regarding the distribution of property remaining on liquidation** and **Section 10 Additional provisions, if any** as outlined on Form 4031 (all members had a copy) as prepared by Industry Canada be adopted in our Constitution. The BOD had previously passed this recommendation.

**Motion:** We, the Membership of Canadian Racing Pigeon Union, recognize the changes Industry Canada has made to the Canada Not-For-Profit Corporations Act (NFP) as outlined on Form 4031, Articles of Continuance (transition) (attached) (October 18, 2014).

## Section 10.01 of the CRPU. Executive Officers

The Executive Officers of the CRPU shall consist of the President, Vice-President, Secretary, and Treasurer, and any subordinate Executive Officer or Executive Officers to fill such subordinate office or offices as may be created by the Board of Directors or the Executive Committee may also be a Director. The immediate Past-President shall serve as ex-officio Executive Officer for one year.

**Wikipedia:** A common misconception is that the participatory rights of ex officio members are limited by their status. This is incorrect, although their rights may be indeed limited by the by-laws of a particular body. Robert's Rules of Orders, Newly Revised (10th ed.), clarifies that the term denotes only how one becomes a member of a group, not what one's rights are. It is a method of sitting on a committee, not a class membership. Frequently, ex officio members will abstain from voting, but unless by-laws constrain their rights, they are afforded the same rights as other members, including debate, making formal motions and voting.

## Robert's Rules of Order

If the ex-officio member is not under the authority of the society, he has all the privileges, including right to vote.

Any member can read about this in the Robert Rules of Order (10th ed.) It clearly states that ex-officio has the right to vote in any issues related to the CRPU. Hopefully this will clarify any questions from members.
