5. Action Items List

5.1 Year Book 2013- Tom's Post

5.2 Membership Dues 2015

- Tom has proposed we change our membership year from the calendar year to the fiscal year to avoid deferred income on our financial statements.
- The membership "year" is not defined in our Constitution.

Tom led this discussion and explained the benefits of changing our membership from the calendar year to the fiscal year for 2015. There are cash flow positives and band order positives.

After discussion Tom tabled this agenda item for later discussion.

5.3 Memberships 2014

- On January 24th last year we had 730 paid up members.
- To date we have 616 paid up members
- We are 114 members behind last year.

These conversations are often lead by non-CRPU members interested in destroying the CRPU.

The hard work of the BOD this past two years in trying to save the CRPU and all the work we have done in challenging bylaws to save our sport are not recognized or mentioned.

All we can do is continue to take the high road, recognizing our term is coming to an end and new BOD members will form the next Executive.

5.4 By Law Updates

Neufchatel Quebec

- This is a new bylaw challenge.
- Mr. Jacques Baillargeon a 25 year member of the CU is in trouble.
- Jacques updated us on this newest challenge.

Mr. Baillargeon was charged for keeping pigeons contrary to a municipal bylaw. He plead not guilty and was represented by Counsel he retained. A conviction was registered and Mr. Baillargeon is appealing the decision.

Unfortunately Mr. Baillargeons' Counsel has been appointed as a Municipal Judge and he is unable to represent Mr. Baillargeon.

What can the CRPU do for Mr. Baillargeon? A lively discussion centered on this issue. Our policy is to get involved at the first step. This one is different. It becomes very difficult to help because an appeal is based only on the written record of the trial.

Jacques will call Mr. Baillargeon and advise we do not know how we can be of assistance at this stage of the proceedings.

Town of Amherstburg ON

- Brad Wogan has been keeping the BOD apprised as to what is happening in Amherstburg.
- This matter was expected back before Council on Monday January 20th but it was not dealt with that date.
- The best I can confirm at this point is the matter is to be rescheduled for a February meeting date.

City of Hamilton ON

- Mr. Bill Young has completed his report for the Planning Committee.
- Cor Ubbles, our Counsel, Ms. Devon Ryerse and I met with Mr. Young on October 2nd and put forth our recommendations.
- It is believed all our recommendations are captured in the report.
- The report is scheduled to go before the Planning Committee on February 18th as a consent item.
- The clubs are fully aware what is happening.
- Our President will attend this meeting on February 18th to represent the CRPU.

City of Brampton ON

- The OMB hearing date was set for Tuesday April 15th at 10:00 in Brampton.
- Ms. Nazma Ramjaun called on Thursday January 16th advising Counsel for the City of Brampton has requested an adjournment. She provided a list of possible dates for this hearing.
- I have sent this information to our member Mr. Hormoz Pourtarvirdi for his consideration.
- I will advise the BOD when a new hearing date is scheduled.
