## 5.1 Memberships 2014

- This is a big win for the CRPU.

# **City of Brampton ON**

- Notice was received on March 18<sup>th</sup> that this matter will be dealt with on Monday June 23, 2014 at the Provincial Offence Court, Court Room B6 5 Ray Lawson Blvd., Brampton, ON.
- We do not have disclosure from the municipality on this matter.
- Jacques is working on this issue.
- We need the CPFA to get involved in these challenges with us.
- This is the last outstanding bylaw issue to be dealt with by the BOD.

# 5.5 Ricoh Photo Copier

- They are assisting in trying to find someone to buy this lease out.

# 5.6 Communication to Membership

- Nick and Terry have been working on a communication piece to be sent to the membership.
- Topics of this communication piece will include; the future of the CRPU Store. Our building lease expires on March 31, 2015.
- Membership fee for 2015 etc.
- What does the future look like?
- Terry will email the draft of this document to the BOD in the next couple of days.

# 5.7 FCI Membership Renewal

- We have our invoice from the FCI for our 2014 membership dues.
- Cost 100 euro.
- Last year we paid 300 euro for monies owing from 2011, 2012, 2013.
- Since we have renewed our membership with the FCI, aside from the new band specifications we have struggled getting answers to our questions from the FCI.
- Martha van Geel our rep for Canada has tried several times to assist us in getting the answers we seek.
- In an email dated February 27<sup>th</sup> Istvan Bardos promised our questions would be dealt with at their meeting on March 24<sup>th</sup>.
- After yet another call to Martha van Geel, on April 28<sup>th</sup> Istvan Bardos replied to our several questions.
- His response has been shared with the BOD.
- Essentially the FCI has no detailed policy about relations between member countries.
- He suggests we make a National Championship which has a condition that fanciers can participate with a CU band only.
- He acknowledges bands give financial support to the National Organizations.

 He suggests we strike an agreement with the AU / IF with respect to band sales.

## PRO's for Continued Membership with the FCI

- This acknowledgement has been very useful when negotiating with Councils with respect to bylaw offences.
- Not having a membership with the FCI may cloud the air with respect to a definition of an approved band.

## **CON's for Continued Membership with the FCI**

- The cost is expensive; about \$200 Canadian per year which includes \$50 to wire the monies to the FCI.
- The FCI does not seem to be interested in issues with in Canada.
- If we withdraw our membership from the FCI this impacts directly on the Canadian International One Loft Race and the Toronto Trifecta. Both lofts are participants in the FCI Racing Pigeon Grandprix for the Mundial Ranking FCI

## 5.8 Bands 2015, 2016, 2017

- Martha van Geel advises the colour for the 2015 2017 bands are:
- 2015 Silver with logo and name FCI.
- 2016 bronze
- 2017 rouge with white letters
- Hanno Troll (Benzing) advises we have 2 different silver colours available to us; Pantone 428 or FR014 as previously distributed to the BOD.
- The ARPU is ordering their bands in blue for 2015; FR014
- Discussion.
- Do we add the FCI logo and name to our 2015 bands?
- Do we keep the bands exactly the same as last year changing only the colour to the FCI colour, silver?
- Do we order our 2015 bands from Benzing again this year?
- Hanno Troll (Benzing) has been in touch with us to commit to an order with them again this year.
- How many bands do we order for 2015?
- We ended up with 6,000 unsold bands in 2013.
- We reduced this year's order accordingly.
- We have 15,080 unsold CU bands this year.
- Thoughts?

**Motion:** the CU follows the FCI colour requirements for 2015, 2016 and 2017. We produce these bands following all FCI requirements with respect to composition and size EXCEPT we will not add the FCI logo and initials to our bands. Our vendor of record will be Benzing.
