Town of Bradford West Gwillimbury

- The bylaw officer has told John Cordeiro he can keep his racing pigeons for now.
- She left a copy of the bylaw with him.
- She has told him if there are any more complaints about the birds she will have to charge him.
- John has asked the CRPU for assistance.
- A second request has been sent to the town to ascertain what the issue is.

Town of Erin

- A 7.5 meter set back from all property lines is being proposed.
- We have two members in the Town of Erin.
- One member will be in violation of this amendment if it passes.

City of Saskatoon

- Vice-President King advises the City of Saskatoon has just passed a bylaw without input; you must be 20 feet back from a residence or any location where a residence could be built.
